### The Impact of Restructuring on Students

#### What we know today...

When it comes to the UW System Restructuring there are still many unanswered questions as important decisions are still being made. However, much work is being done to help students, faculty, and staff understand the changes happening now and coming next year.

#### Advising

Students on the three campuses will continue to receive advising on their “home” campus from the same faculty and staff as before the restructuring. The current UW Colleges Associate Degree requirements will remain in effect for at least one more year ('19-'20) while a group of faculty and staff work to develop a new degree that is reflective of the learning outcomes and needs of students on all three campuses. It is important that the access campuses maintain their transfer mission, which means Advisors on the access campuses will continue to provide advising and support for students choosing to transfer to any UW System campus.

#### Registration

All students will register for Fall 2019 classes in TitanWeb. You may notice when searching for classes that a new field exists to select a campus:

FDL/FOX UW Colleges Courses Online (formerly UW Colleges Online), Fond du Lac, Fox Valley, or Oshkosh. While students can see courses offered at all campuses in TitanWeb, they can only enroll in courses on their home campus. (NOTE: Students with an access campus as their home campus can register for UW Colleges Courses Online. Students who have Oshkosh as their home campus must get permission to enroll in these courses/sections). Those students who wish to take courses on one of the other campuses (up to 6 credits per semester) can complete a [UWO Campuses Student Guest Form](#) on the Registrar's website. Additional tuition and/or fees may apply.

### **Admissions/Transfer**

Students who want to change their home campus for Fall 2019 will need to apply to that campus using the UW System e-app as before. Starting in Spring 2020 students who want to change their home campus will need only to complete a short form to be available on the UW Oshkosh website after July 1.

### **Tuition**

Fall 2019 tuition is not yet posted on the student accounts website. We do know that the tuition for students taking courses at the access campuses is not changing. An access campus student taking courses on the Oshkosh campus will pay the higher baccalaureate credit rate for the Oshkosh course(s). Oshkosh campus students taking courses on an access campus will still be charged the baccalaureate credit rate.
