According to the website, "The Immigration and Nationality Act (INA) requires that the hiring of a foreign worker will not adversely affect the wages and working conditions of U.S. workers comparably employed. To comply with the statute, the Department's regulations require that the wages offered to a foreign worker must be the prevailing wage rate for the occupational classification in the area of employment."
  - ii. Has a list of the top 100 Green Card and H1-B sponsoring companies for each year; also lists the annual salary people typically make working for that company
  - iii. They can also become a candidate, post their resume, and be matched with employers that line up with their interests and professional goals

- 3. Mentoring Programs and Internships:
  - a. Interexchange (http://www.interexchange.org/work-travel-usa/j-1-exchange-jobs/want-work-travel-usa) offers up to 4 month employment terms for international students in the U.S. Once accepted the program will match them with an appropriate employer, serve as their J-1 Visa sponsor, assist with processing the paperwork, provide an orientation session, help them apply for a SSN, provide with accident and sickness insurance, and provide emergency assistance and general support.
    Requirements for eligibility are as follows:
    - i. A full-time college or university student
    - ii. Between the ages of 18 and 28
    - iii. Proficient in English (both written and spoken)
    - iv. Able to work for at least 3 months
    - v. Enthusiastic, motivated, and mature
  - b. They have established a fund that will provide grants of up to \$20,000 to institutions that play host to persecuted academics.
