Course Description

This online course involves a study of government regulations, laws and the influence of ethics on business. A course objective is to prepare students to be able to recognize legal, environmental and ethical problem areas to manage risk. The course generally examines business ethics, environmental and social responsibility, duties of managers and their organizations to their stakeholders by using both local and international examples.

Learning Outcomes/Objectives

The UWO Learning outcome is: Knowledge of the legal and regulatory environment and its applications in an organization to understand the interconnection of ecological and social integrity, and economic well-being.

Upon completing this course, you will be able to:

- o Assess the overall ethical and legal responsibilities of an organization or individual manager from direct in-house interviews at your place of business; and indirect sources such as articles, websites, news and published annual reports;
- o *Identify* the major elements of a sustainability and ethics policy;
- o *Compare and contrast* the potential ethical and legal implications in various organizations via example readings or fellow classmates' presentations;

- o Assess the long-term viability of strategic courses of action; and
- o *Impact* your organization through direct challenges that you choose to tackle as a result of this course.

Course Organization

The course is organized into 3 modules related to the business legal environment: Regulation, Sustainability and Ethics. Specifically, we will discuss how legal issues surrounding sustainability, government regulations and ethics impact your management of risk. We will spend two sessions on each of the three areas.

Students will explore these issues using the online course workbook which contains all of the required readings, videos, YouTube clips and challenging scenarios. We will also explore the topic of personal mindfulness for clarity.

Discussion (300 Pts)

You are required to participate in an online course in the weekly discussions. Grading is a mix of objective and subjective assessment based upon quality of your discussion points and the level of online participation. You can also ask questions and bring in relevant current events to the class in the miscellaneous discussion area.

Each week you should make your first post by Wednesday at 11pm. You should be in a number of times to either post again, read and respond to posts by others in your group by the following Sunday night discussion deadline for that week. Note: I will throw out your lowest score in the total calculation.

Activities (3 @ 200 Pts each)

This assignment requires you to do three different activities (ethics, regulation and sustainability) and write them up (see Appendix for specific assignment details).

Journal (100 Pts)

You will need to prepare a journal in which you answer the questions at the end of each chapter in your workbook. This will include thoughts about the Levelhead app and the various content areas contained therein.

Late Assignment Submission Late submission of assignments is discouraged. Papers turned in after the dropbox due date will be subject to a minimum 1 full letter grade penalty. Papers turned in more than 24 hours after the due date will not be accepted unless there are extenuating circumstances
