Minutes in Brief:

At the March 18, 2014 meeting of the Faculty Senate, Student Affairs Vice Chancellor Petra Roter and Police Chief Joe LeMire discussed the recent shooting incident in Reeve and answered a wide array of questions related to campus security. Academic Computing Director Laura Knaapen discussed the implementation of identity data security measures on campus computers. Environmental Studies Director David Barnhill presented a fossil fuel Divestiture Proposal that was endorsed by the Senate. Graham Sparks reported on the activities of OSA, Greg Wypiszynski gave a Senate of Academic Staff report, and President Neal reported on the recent meeting of the Provost's Staff. The Senate recommended the names of twenty-two faculty for the eleven positions on the Chancellor's Search & Screen Committee. Carmen Heider was appointed to the Institutional Review Board. The Senate approved the Bylaws changes of the History Department and the College of Letters & Science. Senator Loewenstein announced the results of the faculty senate primary election. President Neal announced that senate elections would be pushed back one week and that there may be the necessity for an additional senate meeting May 13.

President Neal called the meeting to order at 3:10 p.m.

I. State of the University -

A. Reports

1. OSA (Sparks) – OSA resolutions at today's meeting include: (1) same sex marriage legalization, and (2) one related to United Council. They will also be voting on a request to move the Veteran's office from first floor of Dempsey to a location on second floor. Elections for OSA are currently running. A committee has been working with Laura Knaapen on establishing some new printing limits for students, (which will run this summer for the first trial test) Page limits would be 1,000 sheets per semester and 500 per summer.
2. SAS (Wypiszynski) – Senate of Academic Staff submitted their names to system for the Chancellor's search committee. Greg apologized for some confusion related to a recent email sent to all instructional staff that was intended only for instructional academic staff. They have since put in a request to have such a list serve created. Spring elections are being held for SAS March 31-April 11. The information survey that was recently done with academic staff to assess how they would like to be more informed, has led to more dissemination of the meeting notices, minutes and agendas. They are currently in the process of starting to look at redesigning their homepage.
3. PAS (Neal) – The meeting mostly pertained to search committee information, noting that the search committee for the AVC for Faculty and Academic staff have started to meet, and the search committee for the Director of USP will soon be under way.

- B. Data Security – Laura Knaapen – Laura gave the senate an update on an upcoming virus scan that Academic Computing will be running. The check will run similar to other current antivirus scans, but the first scan will be done as a light scan to be used as a baseline before determining how necessary additional, more comprehensive scans will need to be done. This scan is set to take place in April.
- C. Divestiture Proposal – David Barnhill – Dr. Barnhill highlighted a handout that was shared entitled ‘An Argument for Fossil Fuel Divestment’, and then answered various questions from Senators related to: reducing our carbon footprint.

**MOTION: Moved to endorse with minor amendments by Bentivenga/Roth. 15 Yes, 1 no, 3 abstentions. PASSED**

- D. Discussion of Security Incident in Reeve – Police Chief Joseph LeMire & Petra Roter - Both Dr. Roter and Chief LeMire informed the Senate of actions made, areas that needed improvement, and issues that are currently being worked on. They answered a variety of questions from senators and noted that new and revised protocols are also being created. The situation was handled for the most part, exceptionally well, with the main areas of improvement identified as communication timeframe and the increased need for risk management for late night events.
