Laura Knaapen and Mark Clements – Student Technology Fee

Laura Knaapen: There are a few changes to the plan that was already previously approved. The first change was that Polk Library requested some new technology for their study rooms. Some of the things listed actually are coming out of the IT Budget directly rather than from the Student Technology Fee because professors really use them the most for their own research.

Jean Kwaterski: You all pay a Student Technology Fee each year so that is really where this money comes from. The UW System has recommendations for how this money should be spent and then the Chancellor ultimately makes the decisions for how the money is spent.

I am hoping that you would be able to act as that committee for the next few years until we have some more flexible spending available. I would hope to get approval from the Senate on these budgets for the upcoming years.
