- 2. Guest: Darryl Sims Athletic Updates: Darryl noted that it was good to see everyone and appreciated the opportunity to provide an update on athletics. He covered retirements, hires, and searches in his division and then went through the standings of each winter sports team and how happy he was with so much success across the board. He covered their preparations to host commencement in Kolf, and answered questions from Senators related to fans attending games and masking options.

- 4. Committee Reports
 - a. President's Report –President Koon reported on the following items:

 - System Presidential Search The committee has it down to five candidates and are moving to the final stages. The goal is to have a new president selected by February;
 - 2022-23 Academic Calendar A fall break factored in the calendar is being proposed with a few options for how it could affect changes to the calendar next year;
 - System is working on a student behavioral initiative focused on mental health and related resources;
 - TTC Appeals Senators were reminded that the deadline for appeals is December 31st. They will continue to have a process in place as we move forward as well;
