

Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA)
Higher Education Emergency Relief Fund (HEERF II) Reporting: Institutional Aid
University of Wisconsin Oshkosh, Report #1 under HEERF II
April 10, 2021

Overview:

The Higher Education Emergency Relief Fund II (HEERF II) is authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 signed into law on December 27, 2020 and provides an additional \$22.7 billion for the Higher Education Emergency Relief Fund. Allocation for awards under Section 314(a)(1) includes both funds for Student Aid (CFDA 84.425E) and Institution Portion (CFDA 84.425F), as described in the Grant Award Notice and the USDE HEERF II Allocation Table under Section 314(a)(1).

On August 31, 2020, the U.S. Department of Education, Office of Postsecondary Education (OPE) posted updated guidance and reporting requirements for HEERF I participating institutions in the Federal Register (Volume 85, No. 169). The revised guidance maintains the same reporting elements at a reporting frequency of every calendar quarter. Each participating institution is responsible for providing a response to the reporting elements, as listed below. Until OPE releases additional guidance for HEERF II funding use, the University of Wisconsin Oshkosh elects to continue posting the information listed below on the institution's primary website, in a format and fashion similar to HEERF I reports. The following information will be easily accessible to the public and updated by calendar quarter thereafter.

The University of Wisconsin Oshkosh hereby addresses questions for CRRSAA Quarterly Report #1, Institution Aid:

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, up to 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to cover any costs associated with significant changes to the delivery of instruction due to the coronavirus*.

UWO Response: *No acknowledgement to the U.S. Department of Education was required for HEERF II funding. Funds were awarded as a continuation of the existing Grant Award Notice received under HEERF I.*

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

UWO Response: *UW Oshkosh received \$8,338,034 in institutional aid funding to cover costs associated with significant changes to the delivery of instruction due to coronavirus.*

UWO Response: *As of March 31, 2021, no Institutional Aid funds have been expended by the recipient.*

Form Instructions

Completing the Form: On each form, fill out the institution of higher education (IHE or institution) name, the date of the report, the appropriate quarter the report covers (September 30, December 31, March 31, June 30), the total amount of funds awarded by the Department (including reserve funds if awarded), and check the box if the report is a “final report.” In the chart, an institution must specify the amount of expended CARES Act funds for each funding category: Sections 18004(a)(1) Institutional Portion, 18004(a)(2), and 18004(a)(3), if applicable. 2020. Each quarterly report must be separately maintained on an IHE's website or in a PDF document linked directly from the IHE's CARES Act reporting webpage. Reports must be maintained for at least three years after the submission of the final report per 2 CFR § 200.333. Any changes or updates after initial posting must be conspicuously noted after initial posting and the date of the change must be noted in the "Date of Report" line.
